International Office in Region Skåne supports internationally educated healthcare professionals with efforts to contribute to a sustainable supply of skills and an inclusive workplace.





### **Status**

#### Right now, the International Office is in contact with:

- Approximately 100 nurses and 100 doctors educated outside the EU, currently on their way to obtaining a Swedish license.
- Other licensed professions we are in contact with include: midwives, 12 biomedical analysts (BMA), dietitians, psychologists, radiology nurses, physiotherapists, and pharmacists.
- Around 30 nurses educated within the EU/EEA.

Since the International Office started in 2021, over 100 healthcare professionals (mainly nurses and doctors) whom we have been in contact with have obtained a Swedish license.



# Language services





### **EU-introduction**



- EU-educated healthcare staff get an insight into how Swedish healthcare works linked to the work environment and communication
- Consists of a theoretical part and a practical two-day auscultation
  - **Theoretical part**: Study material with information about Swedish healthcare culture, communication, teamwork and work environment is distributed to the candidate before auscultation.

- **Practical part:** During the EU auscultation, the auscultator follows a supervisor with the same professional credentials for two full days, with the aim of gaining insight into how Swedish healthcare functions and to highlight potential differences in the work environment and care culture.
- **Result**: A comprehensive introduction to Swedish healthcare for EU-trained professionals, serving as a first step into Region Skåne.



### **Recruitment process**

- Interview with International Office
  - Introduction to Region Skåne and discussion about your profile and expectations
- 2 Matchmaking with Hiring Unit
  - Based on your specialty, experience, and preferences
- 3 Interview with the Unit in Skåne
  - Virtual meeting with managers and potential colleagues
- 4 Visit to Skåne (optional)
  - On-site visit to meet the team and explore the region
- 5 Employment Offer & Relocation Planning
- Once matched, you'll receive a job offer and begin a tailored relocation and onboarding process.

- **Goal: Swedish at C1 level** the required level for professional healthcare practice
- Customised language training begins upon arrival in Sweden
- Language learning combined with workplace practice and daily immersion
- Flexible study pace and methods tailored to each individual's needs and background
- Integrated with **introductory programs** for EU healthcare professionals
